- The VA will not approve benefits for audited courses, Physical Education courses, or for me to retake courses that I have already successfully completed. If I am requesting benefits under the Post 9/11 GI Bill, I understand that my eligibility may change if I am enrolled in online, hybrid, or telecommunication courses (Distant Learning).
- If I change my program, I must submit a VA 22-1995 (Veterans) or VA 22-5495 (Dependents) form to the AACC Financial Aid Office.
- I must submit a copy of my DD214 and transcripts from all my previous colleges** to the AACC Records Office within 90 days of the first time I complete this form. (They must be evaluated for transfer credit.)
- Once I submit this form, the college will automatically postpone my bill payment requirements until the due date listed above. My bill must be paid by this due date. If I decide to drop any of my classes, I must drop them by the deadlines listed in the Schedule of Classes. **They will not be cancelled for non-payment.**
- If I receive 100% Federal Tuition Assistance benefits for a course, I **may not** be able to receive VA benefits for the same course.
- I understand that in addition to my VA Educational Benefits, I may also apply for financial aid at www.fafsa.ed.gov.
- All of my information is correct, and I understand that I must submit a new AACC Veterans Certification Form for each semester.
