

## ARTICULATION AGREEMENT

### Johns Hopkins Schools of Medical Imaging

### Anne Arundel Community College, Associate of Applied Science in Radiologic Technology

Anne Arundel Community College (hereafter referred to as "AACC"), a community college in Anne Arundel County, Maryland and The Johns Hopkins Hospital on behalf of the Johns Hopkins Schools of Medical Imaging (hereinafter referred to as "Johns Hopkins") agree to offer an articulated program leading to the award of an Associate of Applied Science Degree (A.A.S.) in Radiologic Technology by AACC for students who have successfully completed the Johns Hopkins Radiology Program and have been awarded a Certificate in Diagnostic Radiography. They further agree that students with a Certificate in Radiography will be allowed to transfer Radiography core classes to AACC. The following general principles guide the operation of this Agreement.

1. Students interested in pursuing an A.A.S. in Radiologic Technology from AACC may complete courses specific to the Radiography Core at Johns Hopkins Schools of Medical Imaging.
2. Students entering the Johns Hopkins Imaging Program beginning Fall 2013 must have completed all prerequisite/general education requirements with a grade of C or better. The combined grade point average of all prerequisite/general education courses must be 3.0 or better. A minimum of 15 credits must be taken through AACC.
3. Students awarded a certificate in Diagnostic Radiography from Johns Hopkins since 1998 and possessing an active American Registry of Radiologic Technology certification and an active license from the Maryland Board of Physicians to practice Radiography, may be awarded an A.A.S. in Radiologic Technology from AACC upon completion of the prerequisite/general education requirements with a grade of C or better and a combined grade point average of 2.5 or better. A minimum of 15 credits must be taken through AACC.
4. Curriculum modification at either institution must be conveyed in writing to the Vice President for Learning and the Executive Director, Office of Instructional Partnerships, both at AACC, and to the Director of the Johns Hopkins Schools of Medical Imaging within six months of the revision. Students must follow all enrollment and graduation procedures in accordance with AACC policy. Current admission procedures and curriculum are attached hereto as **Exhibit A**.
5. This Agreement becomes effective upon the last signature below. This Agreement shall remain in effect until terminated by either party upon at least 90 days written notice. In addition, either party may terminate this Agreement upon thirty (30) days' notice in the event of a material breach by the other party, and failure to take significant steps to cure the breach within the aforementioned notice period. The parties shall work cooperatively to ensure that termination does not affect students enrolled prior to the date of termination and achieving satisfactory progress are able to complete the program.
6. This Agreement may be dissolved upon mutual agreement of the Vice President for Learning at AACC and the Vice President of Human Resources at Johns Hopkins. Such dissolution will not jeopardize the completion of the program by students then currently enrolled and achieving satisfactory progress.
